1781-1795	<p>Wagon Trade Route 1781-1795 • Pittsburgh to Philadelphia Pennsylvania Robert was a Waggoneer from Pittsburgh to Philadelphia. Along with his neighbor Jack Andrews.</p> <p>"The Great Wagon Road" -He would have used either Braddock or Forbes Road from Pittsburgh to Hagerstown or Chambersburg Respectively. Then used "The Great Wagon Road" from Hagerstown, MD to Gettysburg, Lancaster and Philadelphia.</p> <p>The trip from Philadelphia to Pittsburgh by wagon took between four to six weeks, depending on conditions. Travelers would buy wagons in Lancaster, Pennsylvania, which was known for its wagon-building industry, Wagons were made throughout Lancaster County. 1740-1840 marked the peak time for the building of these wagons, first mainly between Lancaster County and Philadelphia, then on to Pittsburgh, and then eventually to the Pacific. In 1749, historians estimate that 7,000 of these wagons were in use and At their peak, 10,000.</p> <p>Portions of the original roads still exist today, Braddock Road being Route 40. Forbes Road being Route 30 and 11. The Great Wagon Road being parts of Route 11, 81, & 66.</p>

Moved to what is now downtown Pittsburgh - Fifth Street and Diamond ally John Reed is the grandson of Hugh Reed – Who had a log cabin at Fort Ligonier on the Wagon road and had a wagon trade. I wondered if they ran wagons together

1801 Age 56	Will Robert’s will was written in 1801 Allegheny County, Pennsylvania, USA Robert’s 1801 will lists his daughters but not his son(s). This may be due to Robert's father's will which states "I will and order my son Robert to pay his son John Twenty pounds according to his promise when I did convey to him the half of my land." Or it may be because the daughters needed to be ensured that they had source of income, but his son was already settled on his own as he was older. He leaves much more security to the two youngest daughters (homes to be rented to provide money for them for “clothing, schooling and maintaining them” and after his debts had been paid any remaining money was to be split between the two youngest daughters). They were 15 and 21 at his death.
1804 Age 59	Death May 1804 • Pittsburgh, Allegheny Co., PA Probate
